



# MEMBERSHIP TO NATIONAL ALLIANCE OF AGRICULTURAL CO-OPERATIVES IN UGANDA (NAAC)

## 1.0 What is NAAC?

The National Alliance of Agricultural Co-operatives in Uganda (NAAC) is an umbrella organisation of all Agricultural Co-operatives in Uganda, with a mission to provide sustainable high-quality holistic agricultural and co-operative support services to its members and partners.

## 2.0 Membership to NAAC

All Secondary and Tertiary level agricultural co-operatives in Uganda. NAAC byelaws allow primary co-operative societies to become members **only when they are engaged in unique and newly introduced value-chains, upon approval by the AGM.**

The application should be accompanied by a certified copy of a resolution passed at the general meeting authorizing the application of the society to NAAC.

## 4.0 Subscriptions, Shares and other Financial Obligations of Members

In line with article 3 of NAAC's byelaws, the financial obligations for all members of NAAC shall be as follows;

- i) Membership/Entrance fees (One-off payment) - UShs. 20,000/=
- ii) Shares - at least 1, each of UShs. 100,000/= and an annual purchase of at least one extra share
- iii) Annual subscription fee - UShs. 50,000
